Parents and Participants are expected to:

- Encourage members of both teams.
- Keep all comments positive.
- Only officials, players, coaches and team mom are allowed on the field for practice and games, no exceptions.
- Leave the coaching to the coaches.
- Understand that criticizing the officials, coaches and opponents is not acceptable.
- Abusive language and cursing will not be tolerated.
- Be responsible for all family members and friends attending games to support your child.
- Report violations and concerns to a head coach or board member. Do Not be afraid to get involved.
- A parent or guardian must be present at the field with your child AT ALL TIMES.
- Parking is restricted to designated areas.

I understand that repeated violations may result in participants being removed from the field, spectators being prohibited from returning to the facility, or other actions as deemed necessary by the board of directors. All decisions of the board are final.

I understand that we are expected as parents/guardians to conduct ourselves in a civil manner at all LVGYSA sponsored events and failure to do so could result in expulsion from the event by the host organization and or league officials.

I understand that the consumption of alcohol and use of tobacco products at games and sponsored events is strictly prohibited.

\_\_\_\_\_ I the undersigned, do hereby grant to TYFA, LVGYSA and/or PONY the unrestricted and exclusive right and permission, free from approval or review, to copyright and/or use my child's likeness in any and all media now or hereafter known, including but not limited to, pictures and videos of which my child may be included intact or in part for promotion or other commercial use.

\_\_\_\_\_ I understand that TYFA, LVGYSA and/or PONY does not provide any medical or accident insurance coverage for my child. I assume all risks and hazards incidental to such participation.

\_\_\_\_\_ In the event of an injury to my child, I hereby grant authority to a qualified physician to render such medical treatment as said physician deems necessary under the circumstances.

\_\_\_\_\_ I understand I am responsible for the return of all equipment issued to my child by LVGYSA when asked and that I am fiscally responsible for any costs for the excessive damage or loss of said equipment. I understand that if I do not return or pay for the equipment that my child can be put on HOLD until I resolve the situation. I understand that to be put on HOLD will not allow my child to participate with any other organization in TYFA or any other sport in LVGYSA and/or PONY

\_\_\_\_\_ I agree to adhere to the rules, policies and procedures of TYFA, LVGYSA and/or PONY, and I agree that my status and that of my child's can be terminated with or without cause, and with or without notice, at any time by TYFA, LVGYSA and/or PONY. I agree not to defame or slander TYFA, LVGYSA, and/or PONY or any of its members or do anything that may cause damage to TYFA, LVGYSA and/or PONY's image or identity. **I understand that the consumption of alcohol, tobacco products, profanity or inappropriate gestures is strictly prohibited at TYFA, LVGYSA and/or PONY events.**

\_\_\_\_\_ I agree to indemnify and hold harmless, TYFA, LVGYSA, and/or PONY, all of its agents, employees, or any other person against loss or expense including attorney's fees, by reason of the liability imposed by law upon the TYFA, LVGYSA and/or PONY, except in cases of TYFA, LVGYSA and/or PONY'S sole negligence. TYFA, LVGYSA and/or PONY and myself (hereinafter referred to as the Parties) agree that if any dispute, claim or controversy arises between us, we agree that we will first attempt to resolve the dispute by mediation. If mediation fails to resolve the dispute, the parties agree that any and all claims, controversies or disputes arising shall be settled by binding arbitration. Further, venue for the arbitration proceeding shall be in the city of the Organization or San Antonio, Texas when it involves TYFA. The parties hereto also agree that any award tendered by the arbitrator may be entered as a judgement in any court in Texas as enforceable as an order of said court and the parties hereby submit to the venue and jurisdiction of that court
